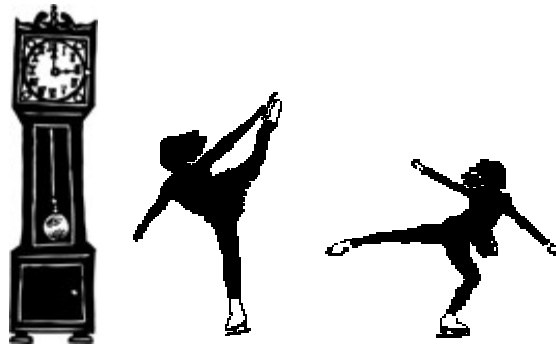
SKATING REMINDERS

PICK HOLES – Skaters not in lessons are **REQUIRED** to fill pick holes at the end of **EVERY** package. Leaving the ice early does not excuse you from filling holes. Your cooperation is appreciated.

ICE ETIQUETTE – The primary right of way belongs to skaters during lessons with coaches. A secondary right of way goes to those having their music played. Other skaters must yield to these skaters. Please be sure to watch out for each other. Do not loiter on the ice.

RINK MONITOR DUTIES - Please make sure the emergency contact information for your skater(s) is up to date in the rink monitor binder. Make any corrections on the sheet and email the corrections to Lynn Derber. Rink monitors are not only present to play CDs, but also the “adults in charge” in case of a medical emergency with a skater. There is a first-aid kit available in the “box” for such emergencies. Rink monitors are also responsible for writing down names of “walk-on” skaters, when allowed, and collecting the fee. A skater can not enter the ice without payment.

No more than 15 skaters are allowed on the ice during any session.
